#### Abstract

The term is a form of words or a combination of words used to express a concept to get a certain meaning. This study aims to describe the characteristic patterns of various language terms during the Covid pandemic 19. This research uses a qualitative descriptive approach where the results of the analysis are described in words but not in numerical form. The subjects in this study used new terms that existed during the Covid pandemic 19. While the object in this study was a characteristic pattern focused on the variety of Covid term languages 19. The technique used was observation and data collection techniques. The results showed that there were 38 data patterns of language characteristics of Covid 19 terms analyzed and then classified into 14 data in English form, 9 data in synonym form, 10 data in abbreviated form and 5 data in acronym form.

#### Abstrak

Hasil penelitian menunjukkan bahwa terdapat 38 data pola ciri bahasa istilah Covid 19 yang dianalisis kemudian diklasifikasikan menjadi 14 data dalam bentuk bahasa Inggris, 9 data dalam bentuk sinonim, 10 data dalam bentuk singkatan dan 5 data dalam bentuk akronim.

Chaer (2010) states that the variety of language can be seen from two views. First, the variation or variety language is seen as a result of the social diversity of speakers of that language and diversity of language functions. Second, the variation or variety of language already exists to fulfill its function as a means of interaction in community activities that various. Oktavia (2018:318) said that the variety of languages is types of language variations whose use is adjusted to the function and situation, without ignoring the basic rules that apply in the language be delivered.

Synonyms are semantic relationships between words that have similarity of meaning according to the purpose of its use. In addition, Utami (2010:19) said that synonym is a semantic study of the similarity of words allows a group of synonym pairs to be formed. So the word group which have similarities will follow the group of synonym pairs. However it is not absolute that synonymous words have the same meaning (Adelin, 2013: 3). So that it can be interpreted if there are words or expressions that have phonemically, the meaning that appears will also be different on the nuances. An abbreviation is a letter or a group of letters as a form of short for a word or several words. Octavia (2018:320) states that abbreviations are also often used in several oral and writing. In writing the abbreviation must be in accordance with the written form according to PUEBI (General Guidelines for Indonesian Spelling). Wider Arisanti (2018:107) abbreviations are words or combinations of words that are written and the speech is abbreviated. An abbreviation is a form of a term whose writing shortened in three ways, namely abbreviated combination letters, combined abbreviations letters and numbers. Muslich (2009:168) says that the abbreviation of the combination of letters is a shortening or abbreviation of words from a certain combination of letters, while the abbreviations for letters and numbers are abbreviations consisting of letters and numbers.

A short word formed by combining letters, syllables, or other parts of words that are written and pronounced separately. Besides An alternative definition of the acronym is an abbreviation of two or more words that is used interchangeably with the original words. In accordance with typical Indonesian word patterns, acronyms are typically created with care for the harmony of words from a variety of arrangements of vowels and consonants, making them simple to understand and remember (Firth, 1957). Acronyms are the result of the process of acronymization. The abbreviation of two or more words to form a new word occurs naturally during the process of creating a meaning or concept that is displayed in the form of words (Pateda, 2001). The term "acronym" can be interpreted in two different ways: as a combination of syllables or as a mixture of syllables and other letters. Syllable compound acronyms are self-names that combine multiple syllables and letters, all of which begin with a capital letter. A mixed acronym is one that is a combination of letters, syllables, or both, from a series of words written in all lower case (Muslich, 2009:168).

The development of language in Indonesia is growing rapidly language has now contributed greatly to the development of civilization humans, so that humans can convey and develop his thoughts. Language is something that cannot be separated from life humans because with language, humans can express everything that is in his mind (Saharuddin, 2016:69). Language as a means of communicating can be meaningful when used in everyday life. That way language is used as a reflection of the human mind and becomes the foundation important in survival (Oktavia, 2019:62). Language plays a very important role in certain situations and conditions in general because language can facilitate interpersonal communication in learning and interpret something.
